THE GUIDELINES FOR THE IWL TRUST INDICATE THAT ONLY "IRREVOCABLE AND UNRESTRICTED" GIFTS WOULD BE ACCEPTED. THE INTENTION WAS FOR THE IWL TRUST TO FUNCTION AS A BOARD DESIGNATED QUASI-ENDOWMENT FUND WITH THE EARNINGS TO BE USED FOR GENERAL OPERATIONS. FURTHERMORE, IWLA'S BYLAWS INDICATE THAT 50% OF LIFE MEMBERSHIP DUES AND 80% OF LIFE BENEFACTOR DUES WOULD BE SET ASIDE IN THE IWL TRUST. THE BOARD-DESIGNATED NET ASSETS WITHOUT DONOR RESTRICTIONS RELATED TO THE IWL TRUST TOTALED \$0 AS OF DECEMBER 31, 2024 AND 2023.

THE BOARD OF DIRECTORS HAS ALSO APPROVED A MOTION TO ESTABLISH A FUND FOR CATASTROPHIC AND UNBUDGETED REPAIRS AND MAINTENANCE OF PROPERTY, INCLUDING THE BUILDING. THE BOARD-DESIGNATED NET ASSETS WITHOUT DONOR RESTRICTIONS RELATED TO THE MAINTENANCE OF PROPERTY TOTALED \$250,000 AS OF DECEMBER 31,
